\$30 for 10 X 10 Inside space **(Limited Electricity – First come First serve)**

**EXHIBIT INFO:** Spaces will be first come first serve. Booth space will be assigned to give balance to the festival. We have some shaded spaces and some full sun. **Be Prepared!** Tents must be free standing, no ropes. **Exhibits can be set up Friday from 5:00 PM – 8:00 PM or Saturday, from 7:00 AM – 9:00 AM only** (No exceptions! No overnight security for Friday night.) **Your space assignment must be picked up at the barn on arrival Friday or Saturday. Vehicles must be moved from display area by 9:00 AM! No Exceptions.** No displays can be removed before the end of the show at 5:00 PM

**DEMONSTRATIONS:** Demonstrations are Encouraged. We encourage handmade original works by the exhibitor. **\*\*Absolutely NO Food items will be sold in craft booths.** Food Vendor Applications are available and **MUST** be submitted separate from this craft application. The committee reserves the right to approve all entries. Exhibitors are asked to display their name.
